Volunteer and the parent or legal guardian thereof if a minor agree that, in consideration for VHC allowing Volunteer's and/or my minor child's and/or legal ward's participation in connection with the Annual Veterans' Holiday Celebration under the terms set forth herein, Volunteer and the parent or legal guardian thereof if a minor, and on behalf of his or her heirs, administrators, personal representative or assigns, do agree to hold harmless, release and discharge VHC, its owners, agents, employees, officers, directors, representatives, assigns, members, affiliated organizations, insurers, and others acting on its behalf (hereinafter collectively referred to as "associates") of and from all claims, demands, causes of action, costs and expenses (including attorneys' fees), and legal liability arising therefrom, whether the same be known or unknown, anticipated or unanticipated, due to VHC's and/or its associates ordinary negligence; and Volunteer and the parent or legal guardian thereof if a minor do further agree that except in the event of VHC's gross negligence and willful and wonton misconduct, Volunteer and the parent or legal guardian thereof if a minor shall not bring any claims, demands, legal actions and causes of action against VHC and its associates as stated above in this clause, for any economic and non-economic losses due to bodily injury, death, property damage sustained by Volunteer and/or my minor child and/or legal ward in relation to the operations and activities of VHC in connection with the Annual Veteran's Holiday Celebration, such operations and activities to include volunteer services occurring both prior to and after the actual Annual Veterans' Holiday Celebration date and whether on or off the actual site for the Annual VHC event located on the grounds of the VA Greater Los Angeles Healthcare System's West Los Angeles facility. Volunteer and the parent or legal guardian thereof if a minor acknowledge that, while Volunteer and/or my minor child and/or legal ward perform such volunteer services for VHC, Volunteer and/or my minor child and/or legal ward shall not be deemed to be nor treated as an employee, agent, subcontractor or independent contractor of VHC or of any agent of VHC and that VHC will not be providing any pay, compensation, insurance, worker's compensation, or any other benefit to which an employee may be entitled. *By signing this release form, Volunteer and the parent or legal guardian thereof if a minor further acknowledge and grant photo release permission for VHC in connection with Volunteer's and/or my minor child's and/or legal ward's volunteer services in connection with the Annual Veterans' Holiday Celebration.*
